- Other relevant government authorities

# 5. Guidelines for Facilities and Location

#### 5.1. Site Requirements

#### 5.1.1. Designated Zone

- RAK DOK must be informed in writing about any proposed modifications, relocations, or expansions of the SBS Swiss Business School campus as part of the approval process.
- SBS Swiss Business School, RAK campus meets environmental sustainability standards, incorporating energy efficiency and eco-friendly materials in its infrastructure.
- SBS Swiss Business School, RAK Campus must secure the necessary permits and approvals from RAK DOK, RAKEZ and other relevant entities to ensure legal and security compliance.

### 5.1.2. Accessibility

- SBS Swiss Business School, RAK Campus is accessible to all individuals, including those with disabilities, in line with RAKEZ's inclusivity policies and UAE federal regulations.
- SBS Swiss Business School, RAK Campus provide easy access to public transport, parking, and other essential amenities to enhance student and faculty convenience.

#### 5.2.1. Building Usage Approval

• Compliance with RAK DOK and RAKEZ Construction and Safety Guidelines is Mandatory
